#### MINUTES OF MEETING OF THE PERCY THOMSON TRUST HELD AT THE STRATFORD DISTRICT COUNCIL ON THURSDAY 18 AUGUST 2022 AT 4PM

#### PRESENT

Chairman Bruce Ellis and Trustees –Christine Craig, Jim Clarkson, Deborah Clough, Doug Robinson and Councillor Gloria Webby.

#### IN ATTENDANCE

The Gallery Director – Laura Campbell (via audio visual link), the Committee Advisor and Executive Assistant – Erin Bishop (minute taker) and Mark Butterworth (Craigs Investment Partners).

The meeting was opened with a karakia.

#### 1. Announcements

The Chairman noted that item 9 – Gallery Director's Report would be held after the presentation by Mr Butterworth.

#### 2. Apologies

An apology was received from trustee Helen Cloke.

#### 3. Presentation

Mark Butterworth, Craig Investment Partners.

Points noted in the presentation:

- The presentation today is to give the Trust the opportunity to look at alternative investment options if it is looking to diversify its portfolio.
- It was noted that Craig Investment Partners look after personal wealth for the vast majority of clients, however it also looks after a number of charitable trusts just as Hospice, Taranaki Foundation, Ostlers Garden Trust and multiple sporting organisations in order to help protect what the organisation has, to continue to grow and generate an income stream from investment portfolios. Portfolios are tailored to suit the needs and desired outcomes from the organisation.
- Craig Investment Partners is one of the largest private investment firms in New Zealand and has about \$25 billion under its management. The size and scale of this gives them an advantage over their peers as they are able to invest heavily in research on the companies that are invested in whether it be globally or locally. They still ensure they can offer the face to face service and are still regional based and live within the communities they work in.
- Protecting capital is the first thing they want to achieve and he acknowledged the significant obligation trustee's have to protect what has been given for generational benefits and the biggest decision for the trust board is to decide on the risk profile. The split for the equities and fixed interest decision will be determined by the risk profiles with most charitable trusts having a 50/50 split. He noted the NZ Super funds were super aggressive with 90% equity for their portfolios partly because this is viewed as multi-generational with very long investment timelines.
- As a business they look at portfolios differently to their peers. A model similar to kiwisaver can be done but would propose looking to invest directly in the market which means the Trust would own the place they have invested in. This is very transparent and important to know what the Trust own to ensure it meets any ethical guidelines anything that is against the values of the trust can be avoided as an investment option. With direct investment the trust makes the investments with guidance from Craig Investment Partners with a goal to protect capital with a sound balance sheet, sound management, dividend yields and future growth potential. The direct model is also very liquid which means if funds are needed urgently then funds could be accessed and into the trust's account in about three days. Direct investment will also incur less fees.
- It was noted that most of the global shares are held in US dollars which can sometimes act in the favour of New Zealand investments.

- He noted the key driver in terms of companies that they invest in is dividend yield (your share of the profits) as it is important that these are increasing to allow investors to continue what they are doing. Long term dividend growth examples from 2001 were provided.
- A portfolio example was presented to the trustees. It was noted that no more than 7% would be invested in one bond for diversification and risk management purposes. Bond portfolios are well laddered with the maturity dates being staggered into the future which means there are bonds regularly maturing to be reinvested.
- The example circulated showed that Craig Investment Partners would be able to put together a fairly good yielding bond portfolios which have exceeded term deposit rates at the moment, however term deposits could also be added into these portfolios as they have no fees. It was noted the only fees are on direct investment/direct security into the market.
- Property investments normally about 3% is put into listed properties. Property has
  increasing interest rates and are under more pressure to maintain capital value and
  maintain dividend pay-outs. As this Trust already has property he would think that no
  more would be put into property.
- Examples were given of New Zealand companies, Australia companies and global companies that are invested in and it was noted that some of these are growing and developing companies. They ensure there is exposure through the global companies in Europe, United States of America, China and Japan.
- It was noted the fees were usually about 0.75% for a charitable trust.
- It was clarified that direct investment would still mean the funds were managed by Craig Investment Partners, therefore would still be compliant with the Trust's Investment Policy with the responsibility being with the Fund Manager and not the trustees.
- The importance of the liquidity factor of these investments was reiterated as funds can be with the Trust in about three days if required.

#### Outcomes

• An Investment Portfolio/Policy Statement Proposal will be created and sent to the Chairman for circulating. The Chairman will suggest a resolution following the receipt of these for the Trustees to consider.

## 4. Gallery Director's Report

The Gallery Director's Report was circulated.

Points noted:

- The Emergence Exhibition has been a real success and an amazing show. There were over 200 in attendance at the prizegiving which did make patrolling mask wearing a bit difficult. The Taranaki Foundation is very pleased with the exhibition and has committed to providing funding for the next Emergence in two years time.
- Visitor numbers are steady but lower than what would be liked. Schools are starting to
  return to the gallery and the gallery is still doing really well despite the lower numbers.
  The Chairman noted the restrictions have impacted openings which usually give
  exhibitions a real kick start but he noted there was a really good presence online via
  the website and social media.
- There has been lots of feedback and engagement online with the Emergence Awards with quite a few sales being made from online posts. Haoro Hond's exhibition has also made a really good connection with Ngāruahine who are very supportive of the gallery.
- Coming up next is Taranaki Arts Trial Preview Exhibition followed by the Adam Portraiture Awards in September which has already arrived and is being stored at the gallery.
- A new platform ladder is required for health and safety purposes.

THAT the purchase of a new platform ladder be approved up to the value of \$3,000

#### ELLIS/CRAIG Carried

• Seeking advice on the temporary storage space as the cabinets are in the wrong place and it will need a refit in the future.

- There was a system malfunction with all contacts stored on outlook being lost. About 400-500 were retrieved and have been collecting addresses again through social media and the people's choice award for Emergence. It was noted that those filling in their details were given the option to be added to the mailing list. Working on future proofing to ensure this sort of loss does not happen again.
- Few leaks in the building from the storm today, one in the staff area, kitchen, foyer and a new one in the shop. It was noted that Mrs Clough had approached Eltham Construction regarding the roof and noted they would need to speak with the Stratford District Council's Property Officer.
- Eftpos Machines with the number of transactions staff are asking customers to go and get cash out for it would be good to implement a credit card system.
- A request was made for the Trust to consider a debit/credit card for operational expenses rather than staff using personal cards and seeking reimbursement. It was noted that Auditors are very cautious of these due to the high risk they carry and are a focus of every annual audit. A credit card with a low limit would be the preference of Mrs Craig. The Chairman and Mrs Craig will further investigate a practical option. It was noted the requirement to use personal cards for items such as online advertising was not ideal.
- Carolyn and Kelvin Squire are looking to purchase the work by Haora Hound created in memory of their son Leon. They have asked if the Trust can provide a space to house it. It was noted this would also require a loan agreement outlining insurance and liability etc. The foyer at the gallery was suggested and protected by Perspex, however it was acknowledged that this area can get very hot and has a lot of sun exposure during summer. The Gallery Director will continue to discuss this with Mr and Mrs Squire and in the meantime the artist will store the work.
- Social media numbers and marketing is going really well with spectacular engagement numbers.
- A request for consideration of a digital screen to be used for marketing in the foyer was made. A quote for \$2,875.90 was presented. On average \$150 is spent on printing and posters for every exhibitions, a digital screen would eliminate this cost. It was noted that the sign in Prospero Place needs to be updated but would not be done until the Council has finalised its town centre/Prospero Place plans. It was noted that the associated hardware and subscription costs were

I refer to your recent application for a grant from Taranaki Electricity Trust.

The Trustees have viewed your application favourably and I am pleased to advise that accordingly your organisation has been granted the maximum sum of \$30,000.00 for the following purposes;

For: Arboretum development

Please note the following conditions which apply:

- 1. The amount granted is the <u>maximum</u> if the work carried out costs less than this, then the trustees may reduce the amount of the grant accordingly.
- 2. The Grant will only be paid when the appropriate claim form is submitted, along with copies of suitably itemised invoices specifying all the work carried out. The Trustees must be satisfied that the amount granted is only used for the purposes as set out above.
- The Grant will be paid direct to your organisation. Any accounts incurred must not be in the name of Taranaki Electricity Trust.
- 4. Any items purchased should be from businesses within the TET area, unless they cannot be sourced locally or the price is substantially different.
- 5. The trust is not registered for G.S.T., therefore G.S.T. will not be added to the amount granted.
- 6. A signed declaration form will be required on completion of the project.
- 7. TET may request further verification of funds spent, following the final draw down of your grant
- 8. The Grant must be uplifted within 12 months. After this the Grant may lapse at the discretion of the Trustees.
- 9. In the case of equipment supplied, an agreement may be required to be signed. This agreement specifies certain terms and conditions.

The Taranaki Electricity Trust is keen to improve public awareness of the organisations which benefit from grants. Therefore acknowledgment of Taranaki Electricity Trust assistance must be made in any publicity arising from this Grant.

- Visitor numbers As demonstrated in Visitor numbers for current exhibition Adam Portraiture, as of 12 October, there have been nearly 1300 people through. Numbers are increasing but I also believe this is a credit to the high calibre of touring exhibition Adam Portraiture is.

## **Currently on at PTG**

**Adam Portraiture Award 2022** closed 16 October 2022. The most popular exhibition for feedback and visitor numbers this year. Condition report and transit completed by Wednesday 19 October. Off to Pah Homestead in Auckland.

- Carolyn and Kelvin have also offered to donate money for buying a new sound system and microphones for the Gallery great for Openings and Public talks.
- Funding application to TET will be made in February 2023 for Rita Angus exhibition, premier national touring exhibition and a huge show for us to secure! I have meetings set up with Suzanne Porter, TAFT to see if we can work with them to promote the exhibition and boost visitor numbers with a shared event partnership ie. Win tickets to TAFT event when you visit the Gallery.

## Marketing

We randomly surveyed 100 visitors how they found out about the Adam Portraiture Exhibition:

- 78% Facebook/Instagram
- 89% Visual Marketing on Streets ie. Billboards, pamphlets
- 65% Press ads
- 32% Gallery Newsletter
- 28% Gallery Website
- 76% Word of Mouth

The survey demonstrates how important digital and physical marketing is for the Gallery. Street image going forward – working in with the new council will be crucial for the Gallery.

As Director, I want to be involved with the consultation process SDC conducts in 2022/23.

My recommendation in near future would be to review budgets to separate Exhibitions and Marketing budgets accordingly.
