 - \$50.00 Compliance Certificate, and either
 - \$776.00 Application fee for full On Licence, or
 - \$132.00 Application fee for BYO On Licence
3. Within 20 working days after filing this application with the Stratford District Licensing Agency, the applicant must give public notice of the application in the required form. The notice must be published twice in either the Daily News or the Stratford Press, with not less than five days and not more than ten days between the two dates of publication.
4. Within the ten days after filing this application with the District Licensing Agency, the applicant must ensure that notice of the application in the required form is attached in a conspicuous place on or adjacent to the site to which the application relates (unless the Secretary of the Stratford District Licensing Agency agrees that it is impracticable or unreasonable to do so).
