

Application for minor variation

It is the Owner/ Authorised agent's responsibility to notify Council of any changes to the approved plans; minor variations can be provided to the Inspector on site or submitted via the Portal and must be approved before the work proceeds.

If providing minor variations at time of inspection 2 copies must be provided. If approved, one copy will be stamped, signed and left on site and the other copy scanned into Council file.
